PLEASE READ CAREFULLY

1. No person who is suspected of being under the influence of alcohol or drugs will be allowed to adopt.
2. I understand that I am adopting a pet.
3. This animal will be cared for and treated with love and respect. I agree to assume full responsibility for its well-being, including providing adequate and wholesome food, fresh water, shelter from the weather and any veterinary treatment needed to provide for the continued health and well-being of the animal.
4. Dogs will **NOT** be kept on a chain because of, among other things, the health hazards that may occur, the lack of exercise chains prevent and the potential dangers chains may cause such as teasing and trapping the dog with no escape.
5. Dogs will **NOT** be used as hunting or guard dogs. Cats will **NOT** be used as barn cats or mousers.
6. I agree to abide by all city and county animal control ordinances, specifically any leash laws to prevent the animal from roaming and becoming a nuisance animal.
7. It is expressly understood that such animal is **NOT to be sold, traded, or given away for any purpose. It is not to be abandoned.** If I cannot provide for the animal any longer, I agree to return the animal to Animal Care and Control of NYC.
8. Animal Care & Control of NYC reserves the right to refuse to adopt any animal for any reason. Further, the Animal Care and Control veterinarian reserves the right to refuse to adopt any animal for any reason, including the health of the animal.

THE ABOVE IS A LEGAL AND BINDING CONTRACT. BY SIGNING BELOW, ADOPTER(S) AGREES TO COMPLY WITH EACH AND EVERY ONE OF THE CONDITIONS LISTED ABOVE. ADOPTER(S) FURTHER AGREES TO IMMEDIATELY SURRENDER AND RETURN THE ADOPTED ANIMAL(S) TO ANIMAL CARE AND CONTROL OF NEW YORK CITY ("AC&C") SHOULD AC&C DETERMINE THAT ADOPTER(S) HAS FAILED TO COMPLY WITH ANY OF THE CONDITIONS LISTED ABOVE. SHOULD AC&C BE REQUIRED TO TAKE LEGAL ACTION IN ORDER TO SECURE THE ADOPTED ANIMAL(S), ADOPTER(S) SHALL PAY ALL COSTS ASSOCIATED WITH SAID LEGAL PROCEEDING.
