Guidelines for Hosting a Third-Party Fundraising Event

- 1. You may host an event or activity and designate ACC as the beneficiary. (Example: A business organizes a charity auction and donates the proceeds to ACC.)
- 2. ACC can be incorporated into an existing event as a beneficiary. (Example: A company hosts an annual event and asks attendees to bring pet supply donations for ACC.)
- 3. ACC's name and/or logo may only be used with prior written approval from ACC's Marketing & Communications Department and Development Department. All promotional materials that include ACC branding must be reviewed before distribution.
- 4. ACC will not cover expenses related to third-party fundraising events.
- 5. Events must align with ACC's mission and must not conflict with existing ACC fundraising initiatives.
- 6. ACC does not insure any third-party activities. Third-party activities organizers agree to defend and indemnify ACC and the City of New York from any and all claims and liabilities arising out of the activity.
